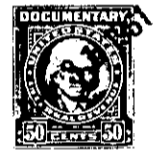
Jacob Franklin Anthony and Eloise P. Anthony, their heirs and assigns forever:

All that lot of land in the County of Greenville, State of South Carolina, in Austin Township, within the corporate limits of the City of Mauldin; and being known as lot 143 of a subdivision known as Glendale, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book QQ at pages 76-77, and having the following metes and bounds, to-wit:

Beginning at a point on the northern side of Fairfield Drive at the joint front corner of lots 143 and 144, and running thence with the northern side of Fairfield Drive, S 84-54 E, 109.6 feet to a point; thence following the curvature of Fairfield Drive with North Golden Strip Drive (the chord of which is N 50-06 E, 35.3 feet) to a point; thence with the Western side of North Golden Strip Drive, N 5-06 E, 23 feet to a point; thence continuing with said Drive, N 7-28 E, 55.4 feet to a point; thence still continuing with the western side of said Drive, N 12-23 E, 72.7 feet to a point at the rear corner of lot 143; thence N 60-01 W, 161.3 feet to a point at the joint rear corner of lots 143 and 144; thence S 5-06 W, 243 feet to the point of beginning.

This deed is executed subject to existing and recorded restrictions and rights-of-way.

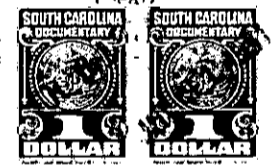
