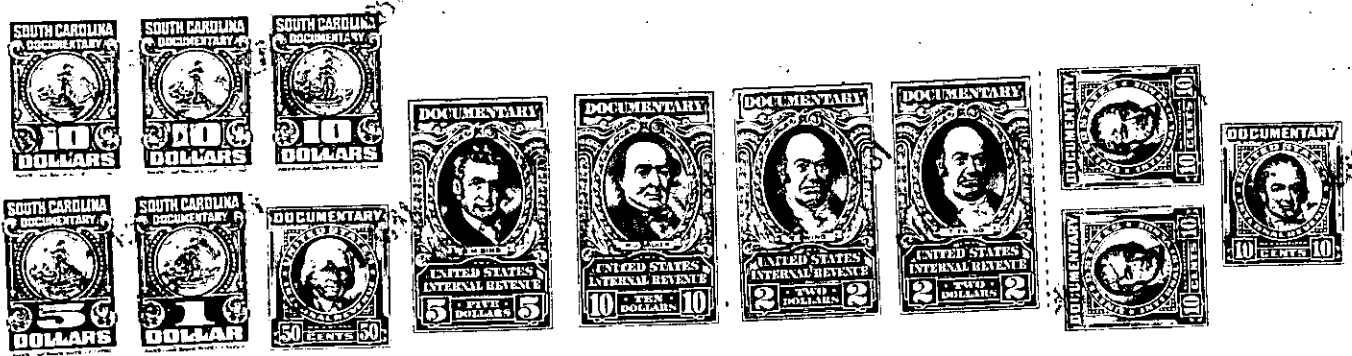


STATE OF SOUTH CAROLINA, GREENVILLE COUNTY
