ALL that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot No. 103 on Plat of Western Hills recorded in the R. M. C. Office for Greenville County in Plat Book QQ at Pages 98-9 and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Alice Farr Drive at the joint front corner of Lots Nos. 103 and 104 and running thence with the common line of said lots, S. 16-30 E. 175.1 feet to an iron pin; thence S. 73-40 W. 100 feet to an iron pin; thence N. 16-30 W. 175 feet to an iron pin on the southerly side of Alice Farr Drive; thence with said Drive, N. 73-30 E. 100 feet to the point of beginning.
