to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said RYLAND C. BRASHIER, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, within the corporate limits of the City of Mauldin, and being known and designated as Lot Number 91 of a subdivision known as Glendale, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book QQ at Pages 76-77, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southern side of Fairfield Drive at the joint front corner of Lots 91 and 92 and running thence with the Southern side of Fairfield Drive S 84-54 E 109.6 feet to a point; thence following the curvature of the Southwestern intersection of Fairfield Drive with North Golden Strip Drive (the chord of which is S 39-54 E 35.3 feet) to a point; thence with the Western side of North Golden Strip Drive S 5-06 W 183.2 feet to a point at the joint rear corner of Lots 91 and 96; thence N 84-59 W 134.6 feet to a point at the joint rear corner of Lots 91 and 92; thence N 5-06 E 208.6 feet to the point of beginning.
