

KNOW ALL MEN BY THESE PRESENTS, that we, William Henry Hudson and Jane Reed Hudson



in consideration of fifty-two hundred and fifty dollars (\$5250.00)

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release G. E. Griffin and Lola Harris Griffin, their heirs and assigns forever:-

All those certain pieces, parcels or lots of land, with the buildings and improvements thereon, lying, being and situate on the southeast side of River Drive, at River Falls, in Cleveland Township, Greenville County, South Carolina, being known and designated as Lot No. 8 and the greater portion of Lot No. 9 as shown on plat of Gool River Heights made by J. C. Hill, Surveyor, September 2, 1947, recorded in the R. M. C. Office for Greenville in Plat Book "S" at page 5, and having the following metes and bounds:

Lot No. 1, BEGINNING at an iron pin in center of River Drive, joint front corner of Lots 7 and 8, and running thence with the line of Lot No. 7, S. 60-00 E. 133 feet, more or less, to a point in center of Gap Creek; thence up Gap Creek following the meanderings thereof in a northeasterly direction, 100 feet, more or less, to iron pin in center of Creek at rear corner of Lot 9, thence with the line of Lot 9, N. 61-00 W. 141 feet, more or less, to iron pin in center of River Drive; theme with River Drive S. 23-30 W. 40 feet to iron pin; thence continuing with River Drive S. 64-30 W. 59 feet to the beginning corner, and being known as Lot No. 8 on the aforesaid plat.

Lot No. 2, BEGINNING at an iron pin in the center of River Drive and running thence S. 54-30 E. 151 feet to the center of Gap Creek, thence up the Creek as the line N. 45-15 E. 88 feet to stake in creek; thence N. 50-60 W. 169 feet to iron pin in the center of River Drive; thence with River Drive as the line S. 34-00 W. 99 feet to a point in said Drive, the beginning corner, and being the greater portion of Lot No. 9 on aforesaid plat. The metes and bounds description to this lot was taken from a more recent survey prepared for Herbert E. and Ester T. Rudd by W. P. Morrow, Surveyor, June 1955, in plat book FF page 315.
