ALL that certain tract or parcel of land situate, lying and being near the Town of Mauldin, County of Greenville, State of South Carolina and described as follows:

A right-of-way fifty(50') feet in width for the construction of a road extending from Hamby Road along the southern line of property of grantor to the property of the Atlantic Coast Line Railroad Company, said right-of-way being shown and designated on plat prepared by Dalton and Neves, Engineers, dated August, 1961, attached hereto and made a part hereof and being more particularly described with reference to said plat as follows:

BEGINNING at an iron pin on the northeastern property line of the Atlantic Coast Line Railroad Company, said pin being N. 57-16 W. 15.7 feet from the intersection of the southeastern side of the railroad right-of-way with said northeastern property line, and running thence N. 57-16 W. 90 feet to a point; thence along a curve to the left with a radius of 85 feet, the chord of which runs N. 57-16 W. 32.8 feet, to an iron pin on the southwestern property line of the grantor; thence along said property line of the grantor, N. 68-29 W. 165 feet to an iron pin on the southeastern side of Hamby Road; thence along the southeastern side of Hamby Road, N. 20-20 E. 50 feet to an iron pin; thence across property of the grantor, S. 68-29 E. 166.1 feet to an iron pin; thence along a curve to the right with a radius of 135 feet, the chords of which run S. 52-07 E. 75 feet to an iron pin and S. 21-07 E. 71.6 feet to an iron pin, the point of beginning.
