That I, W.S. Bradley, in the State aforesaid, in consideration of the sum of Seven Hundred Fifty and No/100----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

J.C. Thurston and Alice C. Thurston

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville and in Bates Township, in the vicinity of Locust Hill, being known and designated as Tract Number Four according to a survey and plat of property of W.S. Bradley made by T.T. Dill August 14, 1946, lying on the East side of the Greenville-Tigerville Road and described by metes and bounds as follows, to wit:

BEGINNING at an iron pin on the East side of the Greenville-Tigerville Road at the corner common to tracts Number 3 and 4 as shown on said plat and running thence along the dividing line between Tracts Number 3 and 4, South 71-10 East 575 feet, more or less, to an iron pin; thence North 28-15 East 360.2 feet to an iron pin at the corner of Tract Number 5; thence along the dividing line between Tracts Number 4 and 5, North 59-45 West 685 feet to a point in the center of said road; thence South 21-28 West with said road 236 feet; thence continuing with said road South 9-28 West 262.2 feet to the place of beginning, containing 5.90 acres.

This is a part of the property conveyed to W.S. Bradley by Hugh F. Goodlett by deed dated February 23, 1946 and recorded in the R.C.C. office for said County in Deed Book 288 at page 97.
