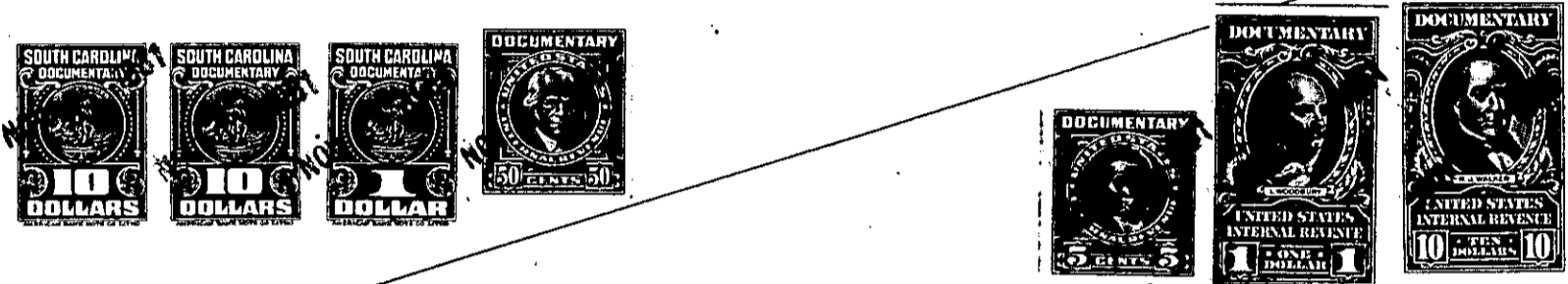


Deed for South Carolina

KNOW ALL MEN BY THESE PRESENTS, NEAL J. HARDY of Washington - successor in office to JAMES B. CASH, JR. D. C., as Federal Housing Commissioner/ Grantor, for and in consideration of the sum of One Dollar (\$1.00) and other valuable considerations, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

ALBERT L. LANDERS & VIDA G. LANDERS Grantee(s), and to the heirs and assigns of said Grantee(s), "All that lot of land in the County of Greenville, State of South Carolina, being a part of Lot No. 26 on plat of H. G. Stevens recorded in Plat Book M, Page 9, of the RMC Office for Greenville County, S. C., and having according to said plat and a recent survey made by R. W. Dalton, March, 1959, the following metes and bounds, courses and distances, to-wit:

BEGINNING at an iron pin on the northwest side of Paris View Drive, front joint corner of Lots 25 and 26; thence with the joint line of said lots N. 55-0 W. 155 feet to an iron pin; thence with a new line through Lot No. 26 S. 35-0 W. 70 feet to an iron pin; thence with a new line through said lot S. 55-0 E. 155 feet to an iron pin on the northwest side of Paris View Drive; thence with the northwest side of Paris View Drive N. 35-0 E. 70 feet to the beginning corner."



TOGETHER WITH ALL and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in any wise appertaining or incident.

TO HAVE AND TO HOLD all and singular the premises before mentioned, unto the said Grantee(s), and to the heirs and assigns of said Grantee(s) forever.

AND THE SAID GRANTOR covenants that he has not made, done, committed, executed or suffered any act or acts, thing or things whatsoever, whereby or by means whereof, the above mentioned and described premises, or any part or parcel thereof, now are, or at any time hereafter shall or may be impeached, charged or encumbered in any manner or way whatsoever.
