to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said MAYLON MYERS, his heirs and assigns, forever:

ALL that piece, parcel or lot of land, situate on the Southeast side of Sentell Road, near the City of Greenville, in Greenville County, South Carolina, shown as Lot No. 3 on plat of Riverdale, made by Dalton & Neves, Engineers, July, 1957, recorded in the RMC Office for Greenville County, S. C., in Plat Book KK, page 107, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southeast side of Sentell Road at the joint front corner of Lots 2 and 3 and running thence with the line of Lot 2, S. 29-49 E., 248.5 feet to an iron pin on the North side of a 36-foot alley; thence with said alley, N. 86-49 E., 148.2 feet to an iron pin; thence with the line of Lot 4, N. 37-0 W., 290.4 feet to an iron pin on the Southeast side of Sentell Road; thence with the curve of Sentell Road (the chord being S. 74-27 W., 99.7 feet) to the point of beginning.

THIS is a portion of the property conveyed to the Grantor herein by deed of Mary Sue Peterson, dated June 7, 1957, recorded in the RMC Office for Greenville County, S. C., in Deed Book 578, page 207.

FOR restrictions applicable to Riverdale, see Deed Book 582, page 93, RMC Office for Greenville, County, S. C., and to the 10-foot drainage easement along the Northeast side of the lot as shown on the recorded plat.

GRANTEE to pay 1961 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.
