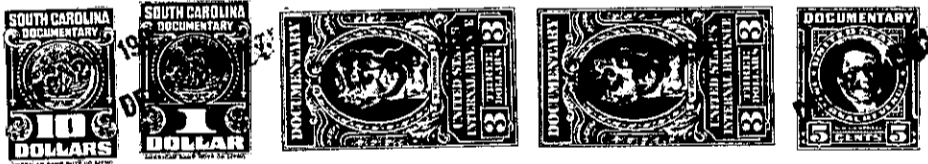
KNOW ALL MEN BY THESE PRESENTS, that WILLIAM R. ALEXANDER

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto BILLY RAY EDENS, HIS HEIRS AND ASSIGNS:

ALL That piece, parcel or lot of land situate, lying and being in the  
City of Greenville, County of Greenville, State of South Carolina,  
being known and designated as Lot No. 64 as shown on a plat of the  
subdivision of Glenn Grove Park, recorded in the RMC Office for  
Greenville County in Plat Book F, Page 233 and having according to  
said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of McAdoo Avenue, which
