the receipt of which is hereby acknowledged, have granted, bargained, sold, and released; and by these presents do grant, bargain, sell and release unto

Bobby K. Garrett and Phyllis M. Garrett, their heirs or assigns:
All that certain piece, parcel or tract of land lying and being situate in Austin Township, Greenville County, State of South Carolina, located on the North-East side of U. S. Highway 276, west of Simpsonville, S. C., being known and designated as lot No. 2 on a plat of property of C. C. Garrett, Sr., said plat made by C. O. Riddle, Surveyor in August 1959, adjoining lands of The Cryovac Company, Styles and Shelton, and being more fully described as follows:

BEGINNING in the center of branch which runs under Highway 276, joint corner with lot No. 1, the center of the branch the line and described by traverse line as N. 58-14 E. 98.3 feet to iron pin; N. 31-12 E. 142 feet to pin; N. 44-31 E. 176.4 feet to iron pin; thence along Styles line N. 10-21 W. 455.5 feet to iron pin; thence along Cryovac line S. 74-30 W. 618.7 feet to iron pin on right of way of Highway 276; thence along said right of way S. 36-20 E. 332 feet to iron pin; thence S. 53-40 W. 2.5 feet to iron pin; thence still along said highway S. 36-20 E. 372.9 feet to the beginning corner, containing 6.59 acres more or less, and being a portion of the same lands conveyed to Clyde C. Garrett and Lois K. Garrett by deed from E. Inman, Master of Greenville County, deed dated July 12, 1950 and recorded in Deed Book 520 at page 82 in the Greenville County R. M. C. Office.
