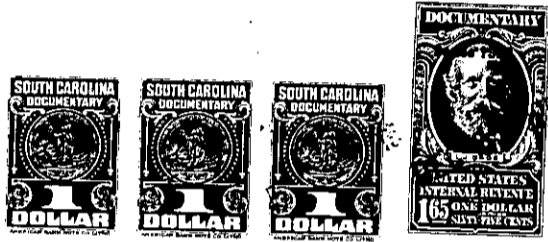
That I, J. Frank Williams
