All that piece, parcel or tract of land situate, lying and being in Austin Township, Greenville County, South Carolina, and being shown as Tract No. 3 on a plat of property of J. F. Maxwell Estate, recorded in the R.M.C. Office for Greenville County in Plat Book YY at Page 39, containing 23.24 acres, more or less, and having, according to said plat, the following metes and bounds, to-wit:
