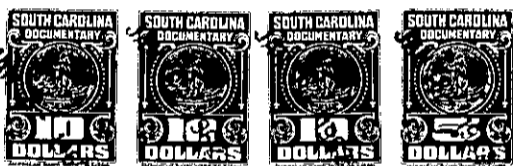
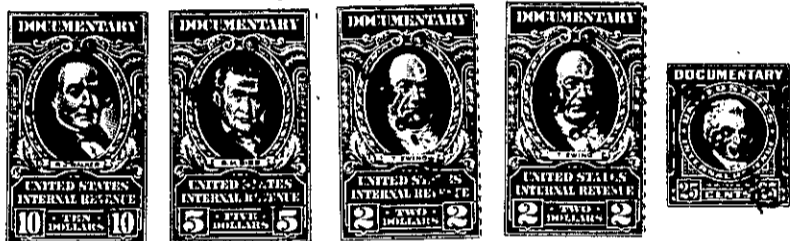
KNOW ALL MEN BY THESE PRESENTS, that Jack E. Shaw and Herbert E. Rudd

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Robert B. Campbell and Marian M. Campbell, their heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot No. 136, of a subdivision known as Orchard Acres, Section Two, as shown on a plat of a portion of said subdivision prepared by J. Mac Richardson, Surveyor, March 1960, and recorded in the R.M.C. Office for Greenville County in Plat Book QQ, at Page 6, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Northway Drive, the joint front corner of lots #136 and #137, and running thence along the line of these lots, S. 5-20 W. 152.3 feet to an iron pin; thence S. 89-14 E. 74.9 feet to an iron pin at the joint rear corner of lots #136, #133, #134 and #135; running thence along the joint line of lots #136 and #135 N. 29-08 E. 139.5 feet to an iron pin on the southern side of Northway Drive; thence along the southern side of Northway Drive the following courses and distances: N. 73-22 W. 98.1 feet to a concrete monument; thence N. 84-40 W. 35.1 feet to an iron pin, point of beginning.
