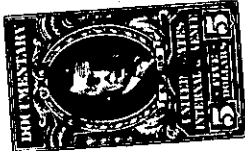

KNOW ALL MEN BY THESE PRESENTS, that **George Peterson**

in consideration of **Five Thousand and no/100** Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

**T. C. Peterson, his heirs and assigns forever:**

**An undivided 1/3 interest in and to:**

**All that lot of land in the County of Greenville, State of South Carolina, in Bates Township, in the Town of Travelers Rest, at the intersection of U. S. Hwy. 25 and Peterson Street, and having the following metes and bounds, to-wit:**

**Beginning at an iron pin on the northwestern side of U. S. Highway 25, which iron pin is situate 25 feet from the center of said highway, at the corner of property of Myrtle T. Tedrick, and running thence along said property, N 37-15 W, 225 feet to an iron pin; thence along T. C. Peterson, S 51-38 W, 198.4 feet to an iron pin; thence along Peterson Street, S 38-30 E, 225 feet to U. S. Hwy. 25; thence with said highway, N 51-39 E, 201.4 feet to the point of beginning and being the same property conveyed to me, George Peterson, in deed book 479 at page 171, and by deed of G. P. Peterson, dated January 4, 1962 to be recorded of even date herewith.**

**Simultaneously with this deed, I am executing a deed of 1/3 interest to Celestine P. Bailey so that the title will hereafter be held by George Peterson, T. C. Peterson, and Celestine P. Bailey as tenants in common, each owning an undivided 1/3 interest therein.**

And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)'s heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
