Know All Men by These Presents:

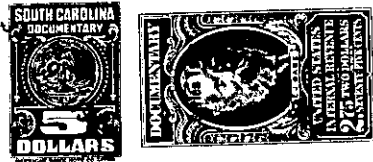

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

J. C. GUNTER, and G. M. GUNTER, their heirs and assigns forever,

ALL that piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, State of South Carolina on the northwestern corner of Lady and Beacon Streets, and being known and designated as LOT NO. 5 on plat of property of W. J. Goodlett Estate, recorded in the RMC Office for Greenville County in Plat Book H, at page 226 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northern side of Lady Street (formerly Walnut Street) at the joint front corner of Lots Nos. 4 and 5, and running thence along the joint line of said Lots, N. 16-50 E. 50 feet to an iron pin; thence S. 73-10 E. 70 feet to an iron pin on the western side of Beacon Street; thence along Beacon Street, S. 16-50 W. 50 feet to an iron pin at corner; thence along the Northern side of Lady Street, N. 73-10 W. 70 feet to the point of beginning.
