All that lot of land with the buildings and improvements thereon situate on the Northeast side of Windermere Drive near the city of Greenville in Greenville County, South Carolina, being shown as lot #13 on map #2 of Cherokee Forest made by Dalton and Neves, Engineers, October, 1956, recorded in the R. M. C. Office for Greenville County, South Carolina in plat book EE at page 190 and 191 and having according to said plat the following metes and bounds to wit:

BEGINNING at an iron pin on the Northeast side of Windermere Drive at joint front corners of lots 12 and 13 and runs thence along the line of lot #12 N 56-30 E, 175 feet to an iron pin; thence N 33-30 W, 100 feet to an iron pin on the Southeast side of Gail Avenue; thence along Gail Avenue S 56-30 W, 150 feet to an iron pin; thence with the curve of Gail Avenue and Windermere Drive (the chord being S 11-30 W, 35.3 feet) to an iron pin on the Northeast side of Windermere Drīve; thence along Windermere Drive S 33-30 E, 75 feet to the beginning corner.
