All that certain piece, parcel or lot of land situate, lying and being
in the State and County aforesaid, **Butler Township, near Rock Hill
Baptist Church Nol., lying north from the road that runs by and in
front of the church, and being a part of the same land that was con-
veyed to me by deed from James Mims and others November 8th 1961, re-
corded in the office of the R. M. C. for Greenville County in Deed
Book 686 at page ;32, and being shown as Lot No. 5 on Plat of Property
of Ebbie Mims made by H. S. Brockman, Surveyor, January 10th 1962,
and having the following courses and distances, to wit:-**

of Lots Nos. 5, 6, 1 and 2; thence with the common line of Lots Nos.

from the above mentioned road along the northern line of Lot No. 3
