(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by

these presents do grant bargain, sell and release unto the said Richard D. Wooten, his heirs and assigns, all my right, title and undivided one-half (½) interest in and to all that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, and known and designated as Lot No. 90 on the plat of Green Valley Estates, prepared by Piedmont Engineering Company, and dated December 20, 1957, which plat is recorded in the R.M.C. Office for Greenville County, alking heavy and the county of the county of

South Carolina, in Plat Book QQ, at pages 2 and 3, and which lot by reference to said plat is more particularly described as follows:

BEGINNING at an iron pin in the Northwest edge of Crapemyrtle Drive, joint front corner of Lots Nos. 89 and 90, and running thence with the joint line of said lots N. 48-10 W. 315.3 feet to an iron pin, joint rear corner of said lots in line of Lot No. 85; thence with the joint line of Lots Nos. 85 and 90 S. 85-24 W. 40 feet to an iron pin, joint corner of Lots Nos. 82, 83, 85 and 90; thence with the rear line of Lots Nos. 81 and 82 S. 6-29 E. 283 feet to an iron pin, joint corner of Lots Nos. 80, 81 and 90; thence with the joint line of Lots Nos. 80 and 90 S. 49-08 E. 138 feet to an iron pin in the Northwest edge of said Crapemyrtle Drive; thence with the line of said Crapemyrtle Drive N. 39-51 E. 215 feet to the point of beginning.
