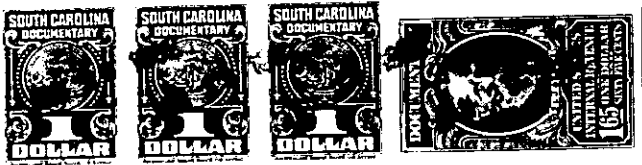
KNOW ALL MEN BY THESE PRESENTS, that I, C. P. Garrett,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto
McLain Hall, his Heirs and Assigns forever:

All that piece, parcel or tract of land situate, lying and being in Chick Springs Township, Greenville County, State of South Carolina on the North side of S. C. Highway No. 253 and containing 2.53 acres, more or less, as shown on plat of Property of John S. Loftis prepared by G. A. Ellis dated April 1945 and being designated as Lot No. 2 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Highway No. 253 at the corner of Lot No. 1 and running thence N. 46 E. 270 feet to an iron pin; thence N. 39 E. 246 feet to an iron pin on the North side of Travelers Rest Road; thence along the North side of Travelers Rest Road N. 61 1/2 W. 258 feet to an iron pin; thence S. 31 W. 510 feet to an iron pin; thence along the North side of Highway No. 253 S. 69 E. 153.5 feet to the point of beginning.
