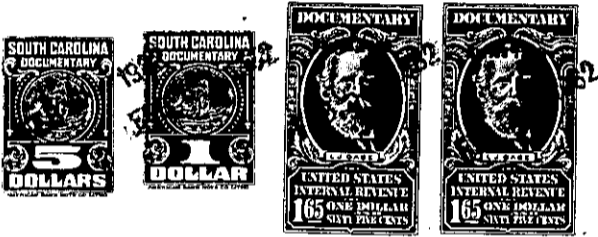
KNOW ALL MEN BY THESE PRESENTS, that M. E. Howell

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Herbert C. Wood, his heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chic, Springs Township, being known and designated as lot #77, of a subdivision known as Wellington Green, as shown on a plat thereof prepared by Piedmont Engineering Service, dated September 1961, recorded in the R.M.C. Office for Greenville County in Plat Book YY at Page 29, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Adelaide Drive, the joint front corner of lots #77 and #78, and running thence along the line of these lots, N. 29-47 E. 175 feet to an iron pin in the line of lot #70; running thence S. 60-13 E. 100 feet to an iron pin at the joint rear corner of lots #77 and #76; running thence S. 29-47 W. 175 feet to an iron pin on the northern side of Adelaide Drive; running thence along the northern side of Adelaide Drive N. 60-13 W. 100 feet to an iron pin, point of beginning.
