All that piece, parcel or lot of land, situate, lying and being on the Southwestern side of Hilltop Avenue in Verner Springs Development, Greenville Township, Greenville County, State of South Carolina, being known and designated as the Northwestern 10 feet of Lot No. 27, as shown on a plat prepared by F. G. Rogers, dated 1908, entitled "Hillhouse Tract" and recorded in the R.M.C. Office for Greenville County in Plat Book A at page 335, and having according to a more recent plat prepared by Piedmont Engineering Service, dated July 18, 1956, entitled "Property of Sans Souci Church" the following metes and bounds:

BEGINNING at an iron pin on the Southwestern side of Hilltop Avenue at the joint front corner of Lots Nos. 27 and 28, and running thence with the line of Lot No. 28, S. 47-30 W. 150 feet to an iron pin; thence with the rear line of Lot No. 16, S. 42-30 E. 10 feet to an iron pin; thence a new line through Lot No. 27, N. 47-30 E. 150 feet to an iron pin on the Southwestern side of Hilltop Avenue; thence along the Southwestern side of Hilltop Avenue, N. 42-30 W. 10 feet to the point of beginning.

This is a portion of the property conveyed to the grantor herein by deed of Emmie R. Thackston, dated July 28, 1954, and recorded in the R.M.C. Office for Greenville County in Deed Book 505 at page 43, and by deed of Emmie R. Thackston, individually and as trustee and administratrix of the Estate of Annie T.
