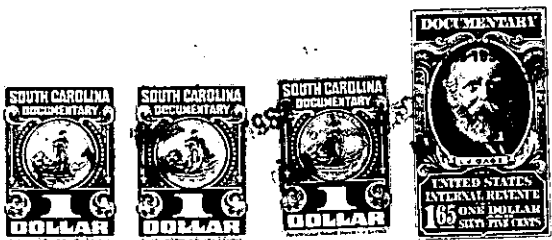
in consideration of the sum of Thirteen Hundred Fifty and no/100 (\$1350.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W.D. Shedd, his heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot No. 90 on Plat of Western Hills recorded in the R.M.C. Office for Greenville County in Plat Book QQ at Pages 98-9, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Tucson Drive, at joint front corner of Lots Nos. 90 and 91, and running thence with the common line of said lots, S. 15-45 E. 200.7 feet to an iron pin; thence N. 73-32 E. 69.6 feet to an iron pin; thence N. 31-09 E. 62.7 feet to an iron pin; thence N. 19-40 W. 160 feet to an iron pin on the southerly side of Tucson Drive; thence with said Drive, S. 69-57 W. 70 feet to an iron pin; thence S. 74-15 W. 20 feet to an iron pin, the point of beginning.

The above lot is conveyed subject to the recorded restrictions applicable to Western Hills, and to the set-back line as shown on said plat.
