ALL that piece, parcel or lot of land in Chick Springs Township, County of Greenville, State of South Carolina, being known and designated as Lot No. 91, as shown on a Plat of Holtzclaw Estates, recorded in the R. That the said property to be used for residential purposes only except lots 1, 2, 3, 4, 47, 48, 49, 50 and 51, may be used for business or church purposes; no residence to cost less than \$ 7,500.00; no building to be erected nearer than 30 feet from the street on which it faces; no lot to be subdivided; this property is conveyed subject to recorded rights-of-way.
