WHEREAS, on or about 1895, Mary T. Garrison made a division of her property among her three children: the Grantee herein, H. S. Garrison, and Suzanna G. Jones, and
WHEREAS, it was the intention to convey by these deeds a fee simple title in the respective tracts to each of the above named children, and
WHEREAS, Mary T. Garrison died intestate on January 10, 1936, leaving as her sole heirs-at-law her three above named children, as will appear by reference to Apartment 376, File 10, in the Office of the Probate Judge for Greenville County, South Carolina, and
WHEREAS, Suzanna G. Jones died intestate on July 30th, 1956, leaving as her sole heirs-at-law her three children, the Grantors herein, as will appear by reference to Apartment 650, File 4, in the Office of the Probate Judge for Greenville County, South Carolina, and
WHEREAS, the deed to Lulah Garrison Patton contained a technical defect which constitutes a cloud upon the title of the Grantee herein;

NOW, THEREFORE,

KNOW ALL MEN BY THESE PRESENTS, That WE, WILLIAM B. JONES, CATHERINE JONES, and JACQUELINE JONES

in the State aforesaid, in consideration of the sum of One and No/100 (\$1.00) Dollar and the premises herein described-----Dollars

to US in hand paid at and before the sealing of these presents by LULAH GARRISON PATTON

quitclaimed
(the receipt whereof is hereby acknowledged), have granted, bargained, sold/and released, and by these presents quitclaim do grant, bargain, sell/and release unto the said Lulah Garrison Patton, her Heirs and Assigns forever:

ALL that tract or parcel of land being in Greenville County containing one hundred and seventy eight acres, more or less and known as the Home Place of Aaron Thompson Est. on the south side of the C. & G. R.R. 4 1/4 miles from Greenville C. H. being Tract No. 3, of the T. J. Turner Est. in Gantt Township and has the following metes & bounds to wit:

BEGINNING at a stone 3xnm between C. & G. RR and the Piedmont Road; thence along the road N 67 1/2 W to a stone on the Negro Church lot; thence along Church lot N 67 1/2 W 4.42 to a stone at corner of Negro Schoolhouse; thence N 76-3/4 W .55 to a stone corner of Yancy Rosemond and M. T. Garrison land; thence S 10 1/2 W 24.45 to a stone on McHughes line; thence S 64-3/4 E 32.40 to a stone in field; thence S 87 E 22.50 to a post oak; thence S 64-3/4 E along school lot to the beginning corner, between R. R. and the Piedmont Road, this survey was made J. N. Southern 20 Nov 93.
