Highway No. 291 (By-Pass) and Tulip Street, in the County of Greenville, State of South Carolina, being shown and designated as portions of unnamed streets on a plat prepared by R. K. Campbell, dated April, 1950, entitled "Property of P. L. Bruce", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book W at page 171, and having according to said plat the following metes and bounds:
