Peden Estate prepared by John C. Smith and recorded in the R. M. C. Office for Greenville County in Plat Book AAA, at Page 39 and having, according to said plat, the following metes and bounds, to-wit:

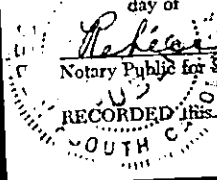
