All my right, title and interest in and to that lot of land in Greenville County, South Carolina, in the City of Greenville and having the following metes and bounds:

BEGINNING at an iron pin 116 feet from the southwest corner of Lloyd Street and Hampton Avenue; thence with Hampton Avenue N. 40 W., 52 feet to an iron pin; thence S. 40-1/2 W., 116 feet to line of property now or formerly of T. Pickens; thence S. 44-1/2 E., 52 feet; thence about N. 40-1/2 E., to the beginning corner.

This is the same property heretofore conveyed by me and D. J. Bull to R. H. Alexander by deed recorded in the Greenville County R. M. C. Office in Vol. 438, page 345. Certain objections have been raised to details of the execution of this deed and the present deed is executed for the purpose of correcting and affirming the prior conveyance.

This is a quit claim deed and the general warranty has been stricken below.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s Heirs, Executors and Administrators to account and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee(s)'s Heirs and Assigns against the grantor(s) and the grantor(s)'s Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
