

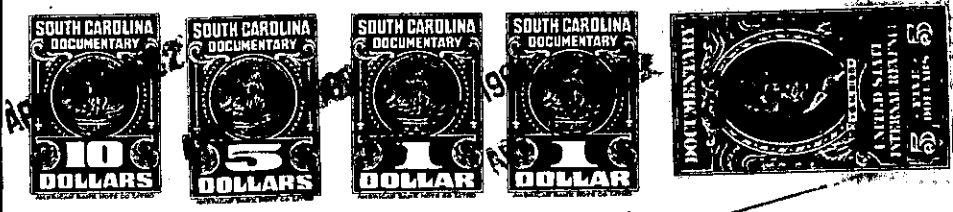
Deed for South Carolina

KNOW ALL MEN BY THESE PRESENTS, NEAL J. HARDY, of Washington -

D. C., as Federal Housing Commissioner, Grantor, for and in consideration of the sum of One Dollar (\$1.00) and other valuable considerations, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto DAVID E. RIGDON and MARGARETHA F. RIGDON

Grantee(s), and to the heirs and assigns of said Grantee(s), ALL that piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 22 on plat of Elizabeth Heights, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book F at page 298, and having according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Western side of Herbert Street, joint front corner Lots 21 and 22, said iron pin being 258 feet North from the Northwest corner of the intersection of Herbert Street and McCary Street and running thence with the line of Lot No. 21 N. 76-15 W. 124 feet to an iron pin; thence N. 13-45 E. 54 feet to an iron pin; thence with the line of Lot No. 23 S. 76-15 E. 124 feet to an iron pin on the Western side of Herbert Street; thence along the Western side of Herbert Street S. 13-45 W. 54 feet to the beginning corner.
