

ALL that certain piece, parcel or lot of land with all the buildings and improvements thereon, situate, lying and being in the State of S. C., County of Greenville, and in Chick Springs Township, being known and designated as Lot No. 7 on plat of property of H. G. Stevens made by W. J. Riddle, Surveyor, April, 1941 and recorded in the R.M.C. Office for Greenville County in Plat Book M, Page 9 and having according to said plat, the following metes and bounds, to wit:
