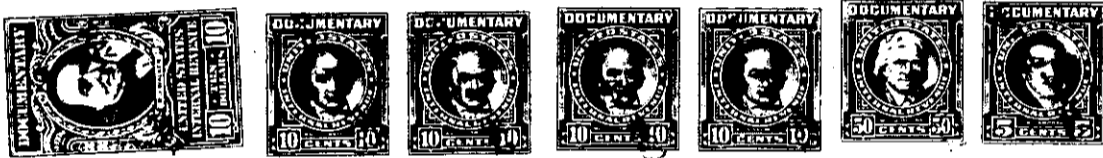
in consideration of Fourteen Thousand Five Hundred and no/100 Dollars,

Henry Berggrun, his heirs and assigns forever:

All that lot of land in the City and County of Greenville, State of South Carolina, known as Lot 1 on plat of North Hills, recorded in the R. M. C. Office for Greenville County in plat book H at page 90, and having the following metes and bounds, to-wit:

Beginning at a point on the eastern side of Bennett Street at the corner of property now or formerly of Branyon, where the northern line of Garraus Street (formerly Swiss Avenue) intersects the eastern side of Bennett Street, thence S 66 E, 150.5 feet to an iron pin; thence N 19-30 E, 85.5 feet to an iron pin; thence N 70-30 W, 150 feet to an iron pin in Bennett Street; thence with the Street, S 19-30 W, 74 feet to the point of beginning.

This is the same property conveyed to Ernest W. Bailes in deed book 560 at page 168. Ernest W. Bailes deceased on November 11, 1961, wherein he devised the above described property unto the grantor as will appear by reference to Probate File 2, Apt. 777.
