All that certain piece, parcel or lot of land lying and being near the Town of Simpsonville, S. C. on the southwesterly side of U. S. Highway No. 276, being the tract formerly used by the Town of Simpsonville for disposal of its sewerage by septic tank, being shown on a plat of the Property of Ida Mae Latimer and J. M. Latimer made by C. O. Riddle, dated June 1959, recorded in the RMC Office for Greenville County in Flat Book "RR", page 1, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on a branch, common corner of three tracts, one belonging to the Grantor, one to the Grantee and the other now or formerly to McLarin, said pin being located S 80-42 W 42.5 feet from the point where said branch intersects the southwesterly edge of the right-of-way of U. S. Highway No. 276, and running thence with the line of property of Grantee S 10-58 W 93 feet to an iron pin; thence N 81-12 W 214.8 feet to an iron pin in a creek; thence with said creek N 18-25 E 83 feet to an iron pin where the branch mentioned above intersects said creek; thence up said branch in a southeasterly direction to the point of beginning.
