BEGINNING at an iron pin on the northern side of Glenn Road at the joint  
front corner of Lots Nos. 10 and 11, and running thence with the joint  
line of said lots, N 14-35 E 250.6 feet to an iron pin; thence along the  
rear lines of Lots Nos. 11, 12, 13, 14, 15, and 16, S 87-30 W 696 feet to  
an iron pin in the joint rear corner of Lots Nos. 16 and 17; thence along  
the joint line of said lots, S 3 W 160 feet to an iron pin in the northern  
side of Glenn Road; thence continuing along the northern side of Glenn  
Road, as follows: along the front of Lot No. 16, N 75-15 E 100 feet to an  
iron pin; thence along the front of Lot No. 15, N 85-20 E 100 feet to an  
iron pin; thence along the front of Lot No. 14, N 89-20 E 100 feet to an  
iron pin; thence along the front of Lot No. 13, N 83-30 E 100 feet to an  
iron pin; thence along the front of Lot No. 12, S 78-26 E 100 feet to an  
iron pin; thence continuing with the front of Lot No. 12, S 47-15 E 50 feet  
to an iron pin; thence with the front of Lot No. 11, S 38-15 E 50 feet to  
an iron pin; thence continuing with the front of Lot No. 11, S 52-10 E  
100 feet to the point of beginning.
