sum of Eighteen Hundred Fifty and No/100 (\$1850.00)-----dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto RALPH C. BELL:

All that piece, parcel or lot of land situate, lying and being on the Southern side of Vicki Circle near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 33, as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R.L.S., in January, 1959, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book Q? at pages 36 and 37, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Vicki Circle at the joint front corner of Lots 33 and 34 and running thence along the curve of the Southern side of Vicki Circle S. 57-15 E. 59 feet to an iron pin, thence S. 25-50 E. 61 feet to an iron pin, thence continuing along the Southern side of said Vicki Circle S. 10-00 E. 96 feet to an iron pin, the joint corner with Lot 32, thence along the line of Lot 32 S. 77-53 W. 210.8 feet to an iron pin, the joint rear corner of Lots 32, 33, and 34, thence along the line of Lot 34 N. 26-35 E. 252.5 feet to an iron pin, the point of beginning.

The premises herein described are subject to a drainage easement at the rear corner as shown on the plat referred to above.

This is a portion of the property conveyed to the grantor herein by deed of Lucile L. Smith, et al, dated September 15, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 634 at page 188.
