All that piece, parcel or tract of land situate, lying and being in Grove Township, Greenville County, South Carolina, containing 4.07 acres and being shown as Tract No. 2 on a plat of the property of Essie T. Taylor prepared by C. O. Riddle, February 1960, and to be recorded, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of S. C. Road No. 50 at the joint front corner of Tracts 1 and 2 and running thence N. 47-31 W. 39 feet to a point in said road; thence up said road N. 41-04 E. 210 feet to an iron pin; thence continuing with said road N. 31-19 E. 75.9 feet to an iron pin; thence continuing with said road N. 25-19 E. 151 feet to an iron pin; thence with the line of tract No. 3 S. 51-25 E. 455.2 feet to an iron pin; thence S. 44-46 W. 460 feet to an iron pin; thence with the line of Tract No. 1 N. 47-31 W. 332.4 feet to an iron pin on the southeasterly side of S. C. Road No. 50 the point of beginning and being a portion of the property conveyed to grantor herein by deed dated March 8, 1941 and recorded in the R.M.C. Office for Greenville County in Deed Book 232, Page 101.
