the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto Wooten Corporation of Wilmington, its Successors and Assigns,

All that certain piece, parcel or lot of land with any improvements thereon, situate, lying and being on the eastern side of Cashmere Drive in Pine Hill Village, Gantt Township, Greenville County, South Carolina, shown and designated as Lot 37 on a plat of Pine Hill Village, prepared by R. K. Campbell, R.L.S., dated November 30, 1960, and recorded in the Office of the R.M.C. for said County and State in Plat Book QQ at Page 169, and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the eastern side of Cashmere Drive, joint front corner of Lots 37 and 38, and running thence N. 75-25 E. 147.1 feet along the joint line of said lots to an iron pin, joint rear corner of Lots 37, 38, 210 and 211; thence S. 29-06 E. 85 feet along the joint rear line of Lots 37, 211 and 212 to an iron pin, joint rear corner of Lots 36 and 37 in the rear line of Lot 212; thence S. 80-41 W. 176.1 feet along the joint line of Lots 36 and 37 to an iron pin on the eastern edge of Cashmere Drive joint front corner of said lots; thence with the eastern edge of Cashmere Drive along a curve, the chord of which is N. 8-33 W. 66.5 feet to an iron pin, the point of beginning.
