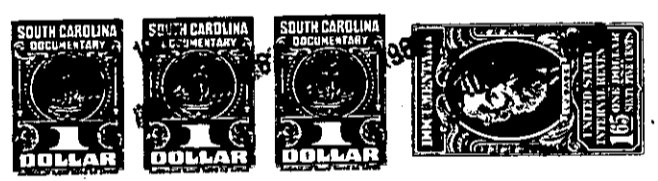
ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 14 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book MM at Page 127, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northwestern side of Salem Court at the joint front corner of Lots 14 and 15 and running thence with the Northwestern side of Salem Court S 34-52 W 160 feet to a point; thence continuing with the curvature of the Northwestern side of Salem Court S 63-51 W 87.5 feet to a point; thence still continuing with the Northern side of Salem Court N 87-10 W 17.6 feet to a point at the joint side corner of Lots 13 and 14; thence N 17-25 E 191.3 feet to a point said point being joint rear corner of Lots 12 and 13; thence N 14-46 E 67.7 feet to a point at the joint rear corner of Lots 14 and 15; thence S 55-08 E 138.3 feet to the point of beginning.
