All that certain piece, parcel and tract of land with improvements thereon, situate, lying and being in the Town of Mauldin, County of Greenville, State of South Carolina, containing 7.44 acres in accordance with plat made for Sarah W. Griffin dated May, 1962, by C. O. Riddle and to be recorded in the R.M.C. Office for Greenville County, and being more fully described in accordance with said plat, to-wit:
