

All that piece, parcel or lot of land, with all improvements thereon, lying, being and situate near the Town of Fountain Inn, Fairview Township, State and County aforesaid, being known and designated as Lot No. 17 in Sunset Heights in accordance with a Plat made of same by W. N. Willis, Engineers, dated October 31, 1958, of record in the R. M. C. Office for Greenville County, S.
