in the State aforesaid, the receipt of which is hereby acknowledged

have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Norman B. Riddley and Sue E. Riddley, their heirs and assigns, FOREVER:

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, designated as lot No. 32 on plat of property of the American Bank and Trust Company, made by R. E. Dalton, September, 1924, and recorded in the R.M.C. Office for Greenville County in Plat Book "F" at page 254, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at a point on the west side of Emile Avenue, 81.5 feet southeast of the intersection of said avenue and Eva Street, and running thence with the said Emile Avenue S. 40-30 E. 75 feet to corner of lot No. 30 on said plat; thence with line of said lot No. 30 S. 49-30 W. 175 feet to rear corner of lot No. 33 on said plat; thence with rear line of said lot No. 33, N. 40-30 W. 75 feet to rear corner of lot No. 34 on said plat; thence with line of said lot No. 34, N. 49-30 E. 175 feet to the beginning corner, and being the northwestern one-half of the property conveyed to me by deed of Laurance Shaver, dated February 6, 1946, and recorded in the R.M.C. Office aforesaid in Deed Book 288 at page 32.

This conveyance is made subject to any restrictions, rights of way, or easements of record, applicable to s#aid property.
