KNOW ALL MEN BY THESE PRESENTS, that we, William J. Keener and Geraldine B. Keener,

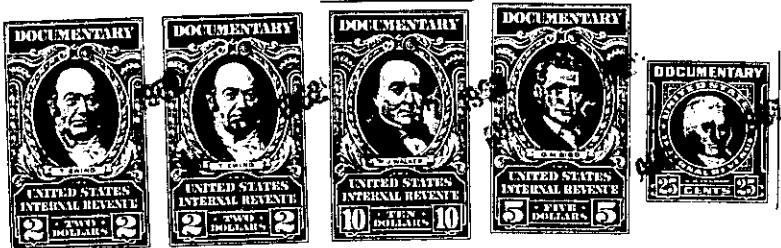
in consideration of Seventeen Thousand Two Hundred Fifty and no/100(\$17,250.00)-----Dollars,
