All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, being known and designated as Lot No. 6 of a subdivision known as Swanson Court as shown on plat thereof prepared by C. C. Jones, C. E., April, 1962 and recorded in the R. M. C. Office for Greenville County in Plat Book YY, at page 73, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Swanson Court, the joint front corner of Lots Nos. 5 and 6, and running thence along the joint line of said lots, S. 33-00 W. 157.8 feet to an iron pin; thence S. 66-04 E. 86.4 feet to an iron pin at the rear corner of Lot No. 7; thence along the line of that lot, N. 33-00 E. 147.1 feet to an iron pin on the southern side of Swanson Court; thence along the southern side of Swanson Court, N. 57-00 W. 85 feet to the beginning corner; being a portion of the property conveyed to me by Dorothy H. Davenport, et al. by deed dated March 30, 1954 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 498, at page 489.
