

BEGINNING at an iron pin on the northeasterly side of By-Pass No. 291 at corner of property heretofore leased by grantor to Texaco, Inc. and running thence with the line of said leased property N. 40-35 E. 175 feet to an iron pin; thence S. 51-41 E. 69.1 feet to a point in line of property of J.
