BEGINNING at an iron pin on the West side of Love Alley and running thence S. 9-26 W. 159.5 feet to an iron pin; thence S. 83-00 E. 140 feet to a point in the center of Richland Creek; thence with the center of 'said Creek S. 27-05 W. 271 feet, more or less, to a point in the center of said Creek; thence S. 76-03 E. 7 feet, more or less, to an iron pin on the east bank of said Richland Creek; thence S. 76-03 E. 122 feet to an iron pin on the West side of Center Street; thence with the West side of Center Street N. 15-23 E. 261 feet to an iron pin on the West side of said Street; thence N. 26-35 E. 262.8 feet to an iron pin; thence N. 23-18 E. 169.8 feet to an iron pin on the South side of Maple Street; thence S. 51-12 W. 92.6 feet to a point in the center of Richland Greek; thence with the center of said Creek S. 7-21 E. 65.9 feet to a point in the center of said Creek; thence still with center of said Richland Creek S. 13-46 W. 104 feet to a point in the center of said Creek; thence N. 75-10 E. 139 feet to an iron pin on the West side of Love Alley, the point of beginning; being the same property conveyed to the Grantor by deed recorded in the R.M.C.
