

County State of South Carolina, located about three miles north of the City of Greer, and being shown as Lots Nos. 19, 22 and 23 on a plat of subdivision known as HOLLIDAY HILL made by John A. Simmons, Registered Surveyor, dated August 5, 1961, recorded in Plat Book RR, page 91, R.M.C. Office for Greenville County, and having the following courses and distances:

LOT NO. 19: BEGINNING on an iron pin at the corner of Holliday and Southern Roads, and runs thence with the margin of Southern Road, N. 4-00 E. 203.4 feet to an iron pin; thence S. 86 E. 200 feet to an iron pin; thence S. 4 W. 66.6 feet to an iron pin on Holliday Road; thence with the margin of Holliday Road, S. 64-10 W. 110 feet to an iron pin and S. 55-50 W. 132.9 feet to the beginning.

LOTS NOS. 22 and 23: BEGINNING on an iron pin on the west side of Motherwell Drive, joint corner of Lots Nos. 21 and 22 on said plat, and runs thence N. 86 W. 200 feet to an iron pin; thence N. 4 E. 216 feet to an iron pin; thence S. 86 E. 200 feet to an iron pin on Motherwell Drive; thence therewith S. 4 W. 216 feet to the beginning corner.
