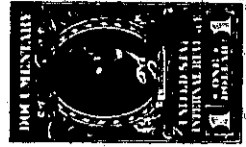

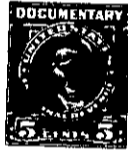


KNOW ALL MEN BY THESE PRESENTS, that We, J. WOLRAWINGS and Mabel M. Rawlings, of Greenville County,

in consideration of Twenty-Eight Thousand, Two Hundred Four and 09/100 (\$28,204.09) Dollars, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto John P. Batson, Jr., his heirs and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as the major portion of Lot 27 of a subdivision known as Wildair Estates according to plat thereof prepared by Dalton & Neves, Engineers, April, 1953 and recorded in the R. M. C. Office for Greenville County in Plat Book EE, at Page 19 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Sheraton Avenue at the joint corner of Lots 33 and 27; thence with the northern side of said Sheraton Avenue, S. 76-20 W. 190 feet to an iron pin in the intersection of said Sheraton Avenue and Burgundy Drive; thence with the curve of said intersection, the chord of which is N. 59-30 W. 36.2 feet to an iron pin on the eastern side of Burgundy Drive; thence with the eastern side of said Burgundy Drive, N. 15-19 W. 96.7 feet to an iron pin; thence continuing still with the eastern side of said Burgundy Drive, N. 12-10 W. 95 feet to an iron pin; continuing still with the eastern side of said Burgundy Drive, N. 10-37 W. 91.4 feet to an iron pin in the line of property formerly owned by Mary Hunter Burch; thence with the line of property formerly of Mary Hunter Burch, N. 83-48 E. 226.8 feet to an iron pin in the line of Lot 32; thence with the line of Lots 32 and 33, S. 10-33 E. 280.36 feet to the point of beginning; being the same property conveyed to us by Betty R. DeMint by deed dated April 9, 1958 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 596, at Page 108.
