the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Luther Ray Stone and Laura S. Stone, their heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, being known and designated as Lot No. 77 of a subdivision known as Western Hills, Sections 1 and 2 as shown on plat thereof prepared by Jones and Sutherland, Engineers, August 1959 and recorded in the R. M. C. Office for Greenville County in Plat Book QQ, at pages 98 and 99 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Alice Farr Drive, the joint front corner of Lots 76 and 77 and running thence along the joint line of said lots, N. 16-30 W. 175 feet to an iron pin on the rear line of Lot 99; thence along the rear line of Lots 99 and 98, N. 73-30 E. 100 feet to an iron pin at the rear corner of Lot 78; thence along line of that lot, S. 16-30 E. 175 feet to an iron pin on the northern side of Alice Farr Drive; thence along the northern side of Alice Farr Drive, S. 73-30 W. 100 feet to the beginning corner; being one of the lots conveyed to us by J.
