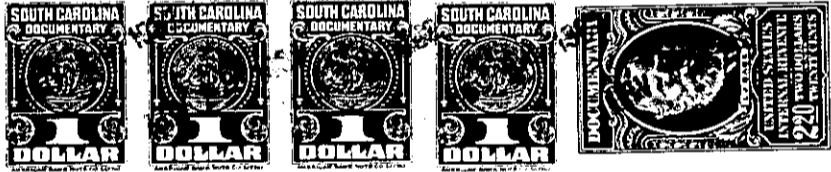

KNOW ALL MEN BY THESE PRESENTS, that Greenville Land Co., Inc.  
A Corporation chartered under the laws of the State of South Carolina and having a principal place of business at  
Greenville, State of South Carolina, in consideration of  
Eighteen Hundred Ninety-Five and No/100 (\$1,895.00) Dollars,  
the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and  
release unto Roy E. Byars and Joan Grey Byars, their heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of  
South Carolina, County of Greenville, Chick Springs Township, being known and  
designated as Lot No. 125 of a subdivision known as Orchard Acres, Section Two,  
as shown on a plat of a portion of said subdivision prepared by J. Mac Richardson,  
Surveyor, March, 1960, and recorded in the R.M.C. Office for Greenville County  
in Plat Book QQ, at Page 6, and having, according to said plat, the following metes  
and bounds, to-wit:

BEGINNING at an iron pin on the northern edge of Ridge Spring Street at the joint  
corner of Lots #55 and #125 and running thence along the rear line of Lots 55 and 56,  
N. 8-27. W. 175.5 feet to an iron pin at the rear corner of Lot 143; thence along the  
rear line of that lot N. 85-36 E. 102.4 feet to an iron pin at the rear corner of Lot  
126; thence along the line of that lot, S. 4-24 E. 175 feet to an iron pin on the northern  
edge of Ridge Spring Street; thence along the northern edge of Ridge Spring Street,  
S. 85-36 W. 90 feet to the beginning corner; being a portion of the property conveyed  
to the granting corporation by Richard F. Watson, et al. by deed dated November 9,  
1959, and recorded in the R.M.C. Office for Greenville County in Deed Volume 638,  
at Page 536.

This conveyance is subject to restrictions and protective covenants recorded in the  
R.M.C. Office for Greenville County in Deed Vol. 648, page 169, and is also subject  
to such drainage and utility easements as appear of record.
