Know All Men by These Presents:

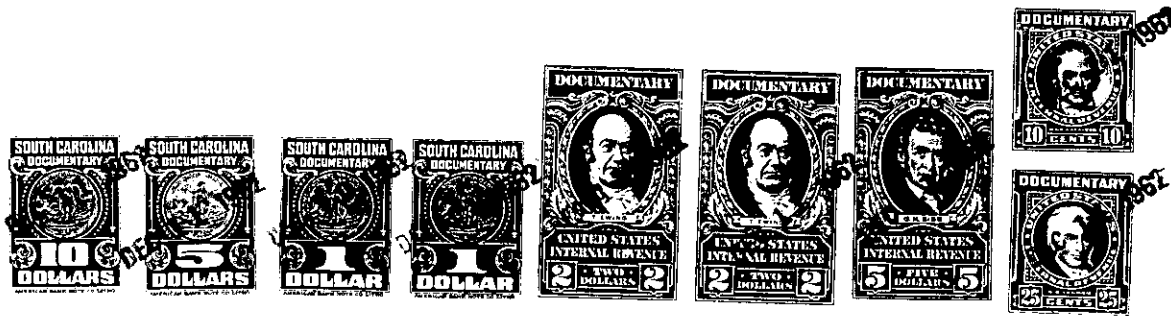
That I, R. D. Wilson
