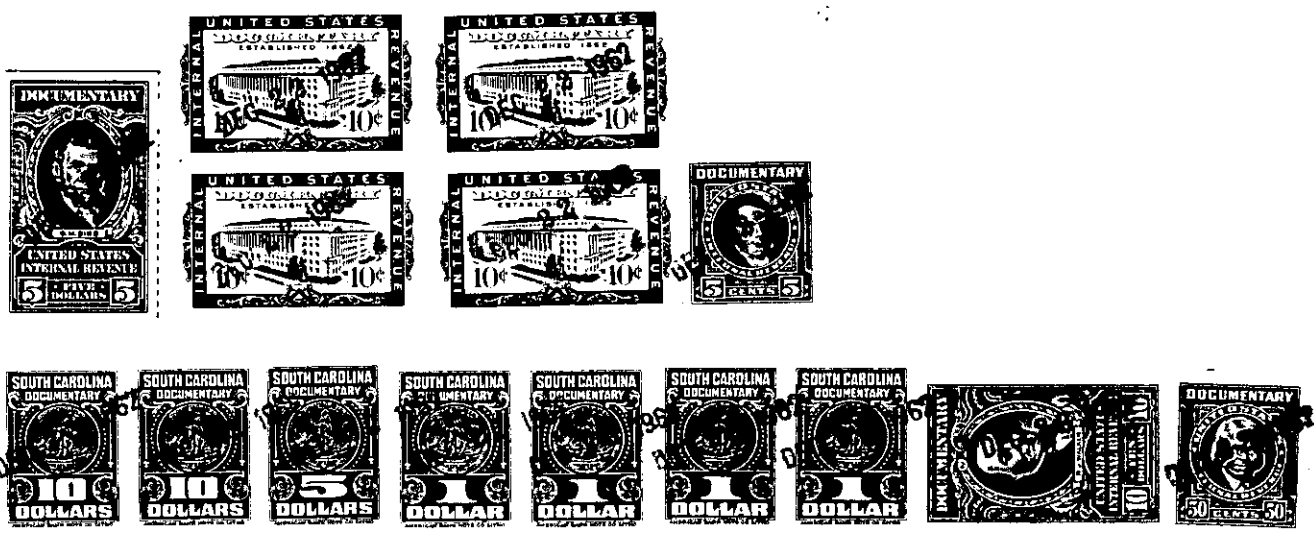

This is the same property conveyed to the grantor by deed recorded in Deed Book 710, page 81.



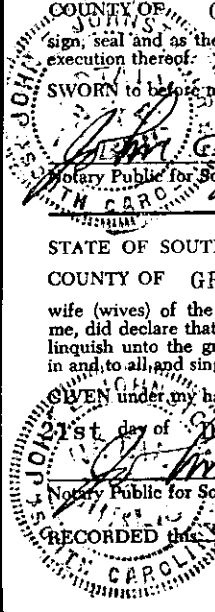
